Definition

Importer: The person(s) physically transporting fish or fish eggs from sources outside New Mexico, across New Mexico state boundaries, for release into New Mexico waters (the person, firm, or agent of the firm listed in Number 10 of this application).

Importation Fee

The following fees need to be included with the application in the form of a check or money order, made out to **Dunn's Fish Farms of Arkansas.**

\$25.00 if your application includes Triploid Grass Carp \$6.00 if your application does not include Triploid Grass Carp
